## AN ORDINANCE OF THE CITY OF UNION GAP, WASHINGTON, ADOPTING THE OFFICIAL ZONING MAP

**WHEREAS**, Chapter 35A.63 of the Revised Code of Washington authorizes the City Council of the City of Union Gap to adopt and amend official controls including zoning ordinances and zoning maps; and,

**WHEREAS**, the City of Union Gap City Council last updated the City of Union Gap Official Zoning Map in 2016; and,

**WHEREAS**, since 2016 the City of Union Gap has rezoned properties, annexed properties and adjusted boundaries between the City of Yakima and the City of Union Gap; and,

**WHEREAS,** the Council has considered these changes and determined that an updated zoning map is needed; and,

# NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF UNION GAP DOES ORDAIN as follows:

Section 1. <u>Official Zoning Map</u>. The designations, locations and boundaries of the zones set forth in Title 17 shall be as shown on the City of Union Gap, WA. Official Zoning Map 2019 attached hereto.

Said map is hereby adopted and controlling over all maps of individual zone boundaries and all notions, reference, data and other information shown thereon, previously adopted by the City Council. The signed copy of the official zoning map attached hereto shall be maintained in the City Hall.

Section 2. <u>Effective Date.</u> This ordinance, adopting City of Union Gap, WA. Official Zoning Map 2019, shall become effective five (5) days following legal publication of this ordinance or a summary of this ordinance.



**SYNOPSIS:** An Ordinance repealing Ordinance 2960 and replacing it with a corrected version which vacates a portion of Lightning Way. This Ordinance corrects the errors from Ordinance 2960 and restates it in its entirety with the corrections

Summaries of the corrections of Ordinance 2960 are:

- a. Creation of a defined term for "Vacated Right-of-Way."
- b. Clarification that the vacation affects the Vacated Right-of-Way legally described in Exhibit A and depicted in Exhibit B.
- c. Clarification regarding Ahtanum Gap's obligation to dedicate the replacement right-ofway and creation of a defined term for "Replacement Right-of-Way".
- d. Clarification regarding the location of the City's retained public utility easement (i.e., the utility easement located within the west 25 feet of the Vacated Right-of-Way).

**RECOMMENDATION:** Approve an Ordinance repealing Ordinance 2960 and restating it with corrections, which vacates a portion of Lightning Way in the City of Union Gap.

## CITY OF UNION GAP, WASHINGTON ORDINANCE NO.\_\_\_\_

AN ORDINANCE repealing Ordinance 2960 and replacing it with this Ordinance which is Vacating a portion of Lightning Way, a public right-of-way in the City of Union Gap, Washington

WHEREAS, the City of Union Gap, pursuant to RCW 35.79.010, passed Resolution 18-65, which initiated the procedure for vacating a portion of the City of Union Gap right-ofway located on the real property described on Exhibit "A," and as depicted on "Exhibit B" (the "*Vacated Right-of-Way*"), both of which Exhibits are attached hereto and incorporated herein, and

WHEREAS, a public hearing was held pursuant to timely legal notice, which was provided by the Union Gap City Council, and the matter of vacating the Vacated Right-of-Way was considered by the Union Gap City Council on January 14, 2019, and

WHEREAS, the City Council of the City of Union Gap, Washington, has considered all matters presented at the public hearing on the proposed vacation and does hereby find that the vacation of the Vacated Right-of-Way is appropriate and that the transfer of property at issue in this matter is in best interest of the public.

WHEREAS, this Ordinance replaces Ordinance 2960 which Council approved on January 14<sup>th</sup>, 2019, and

WHEREAS, a draft version of the Ordinance was inadvertently included in the Council packet on January 14<sup>th</sup>. This draft which was passed as Ordinance 2960 had some errors contained in it that requires correction and thus this Ordinance corrects those errors, and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF UNION GAP DOES ORDAIN as follows:

Section 1. The Vacated Right-of-Way located on the real property described on the attached Exhibit "A" and depicted on attached Exhibit "B" is hereby vacated.

Section 2. As a condition to the passage of this ordinance, the property owner of Yakima County Assessor's tax parcel No. 191206-33416 shall convey the real property described on attached Exhibit "C" and depicted on attached Exhibit "B" for purposes of public right-of-way dedication (the "*Replacement Right-of-Way*"). This ordinance shall not be effective and recorded until the deed conveying the Replacement Right-of-Way has been recorded with the Yakima County Auditor.

Section 3. Nothing contained in this Ordinance serves to vacate that certain public utility easement lying along the west 25 feet of the Vacated Right-of-Way, as shown on Exhibit "B," and as appears on the face of the Short Plat recorded under Yakima County Auditor's File No. 7335606 for the construction, repair and maintenance of public utilities and services.

Section 4. Ordinance 2960 is hereby repealed and replaced in its entirety with this Ordinance.

Section 5. This ordinance shall be in full force and effect five (5) days after passage, as required by law, or five (5) days after the condition in section 2 is complete, whichever event occurs later. If the condition of vacation as stated in Section 2 is not completed within 120 days of the effective date of this Ordinance, this Ordinance shall be null and void.

Section 6. A certified copy of this ordinance shall be recorded by the Union Gap City Clerk with the Yakima County Auditor within ten (10) days of its effective date.



Section 4. Ordinance 2960 is hereby repealed and replaced in its entirety with this Ordinance.

<u>Section 5.</u> This ordinance shall be in full force and effect <u>five (5)</u> days after passage<sub>2</sub> as required by law<sub>2</sub> or <u>whenfive (5)</u> days after the condition <u>isin</u> section 2 is <u>completed after the 5day</u> <u>periodcomplete</u>, whichever event occurs later. Topic/Issue:	Resolution – Amending Resolution 19-01 - Regional Beltway Agreement

**SYNOPSIS:** A resolution amending and restating Resolution 19-01, dated 1/14/2019, which authorized the City Manager to sign the Regional Beltway Agreement. This resolution will acknowledge that the Regional Beltway Agreement included in the packet for Council's 1/14/19 meeting was a *draft*. This new Resolution will be accompanied by the FINAL Regional Beltway Agreement including all exhibits.

Summaries of the changes found in the attached Beltway Agreement redline documents:

- a. Section 5: Clarification that dedication of the Beltway R/W, Tract A, and Tract B will occur on the face of the short plat rather than via quitclaim deed. City Staff and Ahtanum Gap agreed that this was a more streamlined approach to accomplishing the dedication.
- b. Section 9: Amendment to remove reference to the Conceptual Mitigation Plan approved by the Department of Ecology. The provision now simply states that mitigation will occur "in accordance with applicable law."
- c. Corrected references to Arlene Fisher's title as City Manager

**RECOMMENDATION:** Approve a resolution amending and restating Resolution 19-01, which authorized the City Manager to sign the Regional Beltway Agreement.

A **RESOLUTION** Amending and Restating Resolution 19-01, which authorized the City Manager to sign the Regional Beltway Agreement.

**WHEREAS,** On January 14, 2019, the City passed Resolution No. 19-01 which authorized the City Manager to sign the Regional Beltway Agreement;

**WHEREAS**, Resolution No. 19-01 included a draft Regional Beltway Agreement and not the Final negotiated version of the Agreement;

**WHEREAS**, this resolution acknowledges that the Regional Beltway Agreement included in the packet for Council's 1/14/19 meeting was a draft and this new Resolution is accompanied by the FINAL Regional Beltway Agreement with all exhibits and,

WHEREAS, final agreement amends the following;

- a. Section 5: Clarification that dedication of the Beltway R/W, Tract A, and Tract B will occur on the face of the short plat rather than via quitclaim deed. City Staff and Ahtanum Gap agreed that this was a more streamlined approach to accomplishing the dedication.
- b. Section 9: Amendment to remove reference to the Conceptual Mitigation Plan approved by the Department of Ecology. The provision now simply states that mitigation will occur "in accordance with applicable law."
- c. Corrected references to Arlene Fisher's title as City Manager.

**WHEREAS**, it is the desire of the City Council to enter into the final negotiated version of the Regional Beltway Agreement with attachments.

# NOW, THEREFORE, BE IT RESOLVED BY THE UNION GAP CITY COUNCIL as follows:

That the City Manager is authorized to sign this final negotiated version of the Regional Beltway Agreement between the City of Union Gap and Ahtanum Gap, LLC, known as the Regional Beltway Agreement.

# **REGIONAL BELTWAY AGREEMENT**

#### EFFECTIVE DATE: \_\_\_\_\_, 2019

PARTIES: AHTANUM GAP, LLC, a Washington limited liability company (referred to in this Agreement as "Ahtanum Gap")

#### CITY OF UNION GAP,

a Washington municipal corporation (referred to in this Agreement as the "*City*")

**BACKGROUND.** On March 9, 2015, the City passed the below-described RBBA Ordinance for the purpose of funding part of the private funds needed to construct a portion of the below-described Regional Beltway. The portion of the Regional Beltway that runs south from Ahtanum Road and across Wide Hollow Creek to the now existing roundabout on West Rose Street has been constructed. The City intends to construct the remainder of the Regional Beltway in the next few years. Ahtanum Gap wishes to support the City's efforts to construct the remainder of the Regional Beltway and now enters into this Agreement for the purpose of (a) dedicating certain land needed for the construction of the remainder of the Regional Beltway and (b) prepaying funds under the RBBA Ordinance. In exchange for Ahtanum Gap is support and commitments under this Agreement, the City makes certain commitments to Ahtanum Gap in connection with certain land that lies within the Regional Beltway Benefit Area created under the RBBA Ordinance.

**AGREEMENT.** FOR GOOD AND VALUABLE CONSIDERATION, THE RECEIPT AND ADEQUACY HEREBY ACKNOWLEDGED, THE UNDERSIGNED PARTIES AGREE AS FOLLOWS:

- 1. **Definitions.** The following terms, when used in this Agreement, have the following meanings:
  - 1.1 "*AG BLA*" means the proposed short subdivision exemption boundary line adjustment as shown on attached *Exhibit E* for the purpose of merging Tract D and a portion of the tobe-vacated Existing North-South R/W into Lot 1 of the AG Short Plat property.
  - 1.2 "*AG Short Plat*" means the proposed Short Plat attached as <u>*Exhibit C*</u> for the subdivision of below-described Parcel 6.
  - 1.3 "*Beltway R/W*" means and refers to the Yakima County, Washington, real property depicted and labeled as the "125' *Public R/W*" on the AG Short Plat, which property will be used by the City for the location and construction of a portion of the Regional Beltway.
  - 1.4 "*Existing North-South R/W*" means and refers to the Yakima County, Washington, real property described and depicted as the "*Existing North-South R/W*" on the Right of Way Exhibit.
  - 1.5 "Parcels 1-4" means and refers to the Yakima County, Washington, property described as "Parcel 1," "Parcel 2," "Parcel 3," and "Parcel 4" on attached <u>Exhibit B</u>, which are commonly referred to as Yakima County Assessor Parcel Nos. 191206-33411, 191206-33412, 191206-33413, and 191206-33414 and are owned by Ahtanum Gap.

- 1.6 "*Parcels 5*" means and refers to the Yakima County, Washington, property described as "*Parcels 5*" on attached <u>Exhibit B</u>, which is commonly referred to as Yakima County Assessor Parcel No. 191206-33416 and is owned by Ahtanum Gap.
- 1.7 "*Parcel 6*" means and refers to the Yakima County, Washington, property described as "*Parcel 6*" on attached <u>Exhibit B</u>, which is commonly referred to as Yakima County Assessor Parcel No. 191206-33403 and is owned by Ahtanum Gap.
- 1.8 "*RBBA Ordinance*" means and refers to Ordinance No. 2871 for the City of Union Gap, Washington, a true and complete copy of which is attached as *Exhibit F*
- 1.9 "Regional Beltway" means and refers the roadway the City intends to construct from Longfibre Road to Main Street as generally depicted in the drawing attached as <u>Exhibit</u> <u>A</u>.
- 1.10 "*Replacement North-South R/W*" means and refers to the Yakima County, Washington, real property described and depicted as the "*Replacement North-South R/W*" on the Right of Way Exhibit.
- 1.11 "*Right of Way Exhibit*" means and refers to the Right of Way Exhibit attached as <u>*Exhibit D*</u>, which depicts Tract C, Tract D, the Existing North-South R/W, and the Replacement North-South R/W.
- 1.12 "*Tract A*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "A*"" on the AG Short Plat.
- 1.13 "*Tract B*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "B*"" on the AG Short Plat
- 1.14 "*Tract C*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract* "*C*"" on the Right of Way Exhibit.
- 1.15 "*Tract D*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "D*"" on the Right of Way Exhibit.
- 2. <u>Vacation of Existing North-South R/W</u>. The City has approved the vacation of the Existing North-South R/W in accordance with the documentation attached as <u>Exhibit G</u>. Within *fourteen (14) business days* following the full execution of this Agreement, the documentation attached as <u>Exhibit G</u> will be fully executed and recorded by the City with the Yakima County Auditor for the purpose of vacating the Existing North-South R/W as set forth therein such that the west half of the Existing North-South R/W will be merged into Tract C and Parcel 5 and the east half of the Existing North-South R/W will be merged into Parcel 6.
- 3. <u>Replacement North-South R/W Dedication</u>. Within *fourteen (14) business days* following the full execution of this Agreement, (a) Ahtanum Gap will execute and deliver to the City the documentation attached as <u>Exhibit H</u> for the purpose of dedicating the Replacement North-South R/W to the City simultaneous with the recording of the Existing North-South R/W vacation documentation under Section 2 above and (b) the City will cause the documentation attached as <u>Exhibit H</u> to be recorded with the Yakima County Auditor.

- 4. <u>Recording of AG Short Plat</u>. The City has approved the AG Short Plat. Within *fourteen (14) business days* following the full execution of this Agreement, the mylar for the AG Short Plat will be recorded by the City with the Yakima County Auditor for the purpose of subdividing Parcel 6 as set forth in the AG Short Plat.
- 5. **Beltway R/W, Tract A, and Tract B Dedications.** The Beltway R/W, Tract A, and Tract B properties will be dedicated for public purposes on the face of the AG Short Plat, a copy of which is attached as *Exhibit I*, when the City records the AG Short Plat mylar under Section 4 of this Agreement.
- 6. <u>Recording of AG BLA</u>. The City has approved the AG BLA. Within *fourteen (14) business days* following the full execution of this Agreement, the required documentation for the AG BLA will be recorded by the City with the Yakima County Auditor for the purpose of completing the AG BLA.
- 7. **Regional Beltway Access Approaches.** The property included within the AG Shot Plat will be allowed *two (2) commercial access approaches* to and from the Regional Beltway that will allow both right and left turns in and out of said property to and from the Regional Beltway. The access approaches will be *thirty (30) feet* in width and otherwise standard in nature for City commercial access approaches. The exact location of the access approaches to and from the Regional Beltway for the property included within the AG Short Plat will be determined and approved by the City and the owner(s) of the property on which the access approaches will be located at the time of said property's development; *provided, however*, it is believed the access approaches will likely be established in the locations generally depicted and labeled as the "Access Points" in the drawing attached as <u>Exhibit J</u>.
- 8. <u>Construction of the North-South Roadway</u>. The City, at the City's expense and with no additional cost to Ahtanum Gap or the owners of any of the Parcels 1-4, Parcel 5, Parcel 6, or vacated Existing North-South R/W property, will fund and construct the north/south connector road through the Replacement North-South R/W for the purpose of connecting the Regional Beltway with West Pine Street when and at the same time the portion of the Regional Beltway that runs through the Beltway R/W is constructed. The City will not allow access approaches along this section of new roadway.
- 9. <u>Wetlands</u>. There are a collection of purported wetlands located on the Parcel 6 property in the approximate locations depicted and labeled as "Wetland 1," "Wetland 2," and "Wetland 3" on the drawing attached as <u>Exhibit K</u>. When the portion of the Regional Beltway that runs through the Beltway R/W is constructed, the City, at the City's expense and with no additional cost to Ahtanum Gap or the owners of any of the Parcels 1-4, Parcel 5, Parcel 6, or vacated Existing North-South R/W property, will mitigate and move off site to property owned by the City, "Wetland 1", "Wetland 2," and "Wetland 3" as generally depicted on the drawing attached as **Exhibit K**, with said Wetlands to be relocated in accordance with applicable law.
- 10. <u>Beltway Fee Payment</u>. In light of Ahtanum Gap's agreement hereunder to dedicate the Beltway R/W, Tract A, Tract B, and Replacement North-South R/W property to the City and Ahtanum Gap's agreement hereunder to prepay the Regional Beltway fee authorized under the RBBA Ordinance that is assessed against the Parcels 1-4, Parcel 5, and Parcel 6 property, the City agrees to reduce and fix the fee assessed under the RBBA Ordinance against the Parcels 1-4, Parcel 5, and Parcel 6 property at *One Hundred Sixty-Four Thousand Four Hundred Forty-Four and No/100 U.S. Dollars (\$164,444.00)* (the "*RBBA Assessment*").

Ahtanum Gap will pay the full RBBA Assessment to the City within *three (3) business days* of the completion of the recording of the documentation for the vacation of the Existing North-South R/W, finalization of the AG Short Plat, and finalization of the AG BLA under Sections 2, 5, and 6 above. The RBBA Assessment, once paid by Ahtanum Gap to the City, will satisfy all assessments now and in the future due under the RBBA Ordinance and any and all existing and future amendments, modifications, and supplements thereof (including, without limitation, any new or additional ordinances or other laws or assessments passed in the future for the purpose of funding the construction of any portion of the Regional Beltway) for the property that comprises the Parcels 1-4, Parcel 5, Parcel 6, and vacated Existing North-South R/W property.

Subject to the terms of this Agreement, the property that comprises the Parcels 1-4, Parcel 5, Parcel 6, and vacated Existing North-South R/W property will be subject to City of Union Gap development requirements at the time of development.

#### 11. Representations and Warranties.

- 11.1 Ahtanum Gap Authorization. Ahtanum Gap represents and warrants to the City that (a) Ahtanum Gap has full power and authority to enter into this Agreement; and (b) this Agreement, when exceuted and delivered by Ahtanum Gap's below-stated Manager, will constitute valid and legally binding obligations of Ahtanum Gap enforceable in accordance with their terms hereof.
- 11.2 *City Authorization.* The City represents and warrants to Ahtanum Gap that (a) the City has full power and authority to enter into this Agreement; and (b) this Agreement, when executed and delivered by the City's below-stated Mayor, will constitute valid and legally binding obligations of the City enforceable in accordance with their terms hereof.
- 12. <u>Binding Effect; Covenants Running with the Land</u>. The provisions of this Agreement are binding on the undersigned parties and their respective heirs, successors, and assigns and constitute covenants and benefits appurtenant to and running with Parcels 1-4, Parcel 5, and Parcel 6 property.
- 13. <u>Memorandum of Agreement</u>. The undersigned parties will not record this Agreement. However, within *fourteen (14) business days* following the full execution of this Agreement, the undersigned parties will execute the Memorandum of Agreement attached as <u>Exhibit L</u> and record said Memorandum with the Yakima County Auditor for the purpose of providing public notice of the existence of this Agreement.

#### 14. General Terms.

- 14.1 *Exhibits.* There are no exhibits or other attachments to this Agreement except for the exhibits expressly referenced in this Agreement, each of which constitutes a part of this Agreement as if set forth in full herein.
- 14.2 *Amendment.* This Agreement may be amended only by the signed written agreement of each of the parties to this Agreement.
- 14.3 **Binding Effect.** All of the provisions of this Agreement will inure to the benefit of and be binding on the successors and assigns of each of the parties to this Agreement.
- 14.4 *Time is of the Essence.* Time is of the essence as to all terms of this Agreement.

- 14.5 *Independent Contractors.* The parties to this Agreement are and will remain contractors independent of each other with respect to the subject matter of this Agreement.
- 14.6 **Construction and Headings.** The captions and paragraph headings used in this Agreement are inserted for convenience of reference only and are not intended to define, limit, or otherwise affect the interpretation or construction of any provision of this Agreement.
- 14.7 *Waivers.* Any party to this Agreement may waive any obligation under this Agreement of the other party to this Agreement, but only if the waiver is made in writing by the waiving party. However, no such waiver will constitute a further or continuing waiver of any preceding or succeeding default of the same or any other obligation under this Agreement.
- 14.8 *Cumulative Remedies.* No remedy made available under this Agreement or otherwise by law is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy given under this Agreement or now or hereafter existing at law or in equity or by statute or otherwise.
- 14.9 Specific Performance/Injunctive Relief. Each party's obligations under this Agreement are unique. If any party should default in its obligations under this Agreement, the parties acknowledge it would be extremely impracticable to measure the resulting damages. Accordingly, the nondefaulting party, in addition to any other rights or remedies available under this Agreement or otherwise by law, may sue in equity for specific performance and/or injunctive relief, and the parties each expressly waive the defense that a remedy in damages will be adequate.
- 14.10 *Governing Law; Venue.* This Agreement will be interpreted and construed under and governed by the state laws of the State of Washington and federal laws of the United States of America. The exclusive venue for any legal action concerning this Agreement will be the Yakima County Superior Court for the State of Washington and the undersigned parties hereby submit to the jurisdiction thereof.
- 14.11 *Attorneys' Fees and Costs.* If any party to this Agreement brings a legal action to interpret or enforce this Agreement, the substantially prevailing party in the action will be entitled to an award of the legal costs and reasonable attorneys' fees said party incurs in the action, whether in arbitration, at trial, on appeal, or in a bankruptcy proceeding.
- 14.12 *Further Assurances.* In addition to the instruments to be delivered as provided in this Agreement (if any), each party to this Agreement, from time to time at the request of the other party to this Agreement, will execute and deliver to the requesting party such other instruments, and will use commercially reasonable efforts to take such other action, as may be necessary or proper to more effectively carry out the intent and provisions of this Agreement.
- 14.13 *Severability.* If any provision of this Agreement is determined to be invalid or unenforceable, that provision and the remainder of this Agreement will continue in effect and be enforceable to the fullest extent permitted by law. Furthermore, it is the intention of the parties to this Agreement that if any provision of this Agreement is capable of two constructions, one of which would render the provision void, and the other of which

would render the provision valid, then the provision will have the meaning that renders the provision valid.

- 14.14 *Entire Agreement.* This Agreement (including all recitals, background information, and defined terms) constitutes the entire understanding and agreement of the parties to this Agreement with respect to its subject matter. All prior agreements, understandings, or representations with respect to this Agreement's subject matter (if any) are hereby canceled in their entirety and are of no further force or effect. It is expressly acknowledged that there are no oral or other agreements which modify or affect this Agreement.
- 14.15 *Counterparts and Copies.* This Agreement may be executed in any number of identical counterparts, with each counterpart having the same effect as if all parties to this Agreement had signed the same document. All executed counterparts of this Agreement will be construed as and constitute one and the same instrument. A facsimile or electronic copy (*e.g.*, a PDF copy) of an executed counterpart of this Agreement will have the same effect as an original executed counterpart of this Agreement.
- 14.16 *Warranty of Authority*. Each of the individuals signing this Agreement on behalf of a party to this Agreement warrants and represents that such individual is duly authorized and empowered to enter into this Agreement and bind such party hereto.







# AG Short Plat




#### **Right of Way Exhibit**

## **RBBA** Ordinance

### CITY OF UNION GAP, WASHINGTON ORDINANCE NO. <u>2871</u>\_\_\_

AN ORDINANCE creating Chapter 11.34 of the Union Gap Municipal Code, entitled "Regional Beltway Benefit Area"; establishing a Regional Beltway transportation benefit area and establishing fees; and establishing an effective date.

WHEREAS, the City Council wishes to adopt a new Chapter 11.34 entitled Regional Beltway Benefit Area, to establish the transportation improvement benefit area, and to establish fees for properties within the improvement benefit area;

WHEREAS, the City of Union Gap has designed and is in the process of constructing road improvements for the Phase 1 of the Regional Beltway consisting of the extension of Longfibre Road to the south across Wide Hollow Creek;

WHEREAS, the Regional Beltway - Phase 1 improvements will provide an additional crossing of Wide Hollow Creek which will increase traffic capacity to the benefit area allowing unrestricted development south of the Creek and better access to and from benefit area properties;

WHEREAS, the new Regional Beltway – Phase 1 road will service a benefit area of at least 333.29 acres (see Exhibit 1 attached to this ordinance) and will service a benefit area minus the flood plain area and future dedicated road right-of-way of at least 221.92 acres;

**WHEREAS**, the cost to construct the Regional Beltway – Phase 1 improvements will require public grant and loan funding of approximately \$1,820,000;

WHEREAS, the City has been awarded grant funding from the Yakima County Supporting Investment on Economic Diversity (SIED) program in the amount of \$500,000 which reduced the balance of City funding required to \$1,320,000;

WHEREAS, based on a required City funding amount of \$1,320,000, the fees for property owners within the benefit area will be assessed at \$5,000 per acre if total fees are paid by December 31, 2015 and \$6,000 per acre for fees paid after December 31, 2015.

WHEREAS, it is the intention of the City that fees be assessed against the property owners within the benefit area set forth in Exhibit 1. These fees are intended as a means for the City to recover its capital costs associated with the construction of the Regional Beltway – Phase 1 improvements identified in Exhibit 1;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF UNION GAP, WASHINGTON does hereby ordain as follows:

Section 1. Union Gap Municipal Code Chapter 11.34, entitled "Regional Beltway Benefit Area" created.

> City of Union Gap, Washington Ordinance – Regional Beltway Benefit Area Page 1 of 3

A new Union Gap Municipal Code Chapter 11.34 is created as follows:

### 11.34 Regional Beltway Benefit Area

A Regional Beltway Benefit Area (Benefit Area) is hereby established for the purpose of assessing fees to recover the City's capital costs in constructing the Regional Beltway – Phase 1 improvements to and within the Benefit Area. The Benefit Area is that area indicated on the attached Exhibit 1.

# 11.34.010 Fees for Properties within the Regional Beltway Benefit Area.

Fees shall be assessed for Regional Beltway – Phase 1 improvements to and within the Benefit Area set forth and depicted in Exhibit 1. Fees shall be assessed to all property owners within the Benefit Area unless the property is located in the area not included within the Benefit Area as depicted in Exhibit 1. Said fees are assessed for the purpose of recovering capital costs associated with the construction of the Regional Beltway – Phase 1 improvements to and within the Benefit Area.

The amount of the assessed fees shall be as follows:

\$5,000 per acre for property within the Benefit Area (Exhibit 1) if payment of fees are paid in full by December 31, 2015

\$6,000 per acre for property within the Benfit Area (Exhibit 1) if fees are paid at any time after December 31, 2015

Fees shall be assessed against all acres associated with each parcel being developed within the benefit area as depicted in Exhibit 1, and shall be paid in full prior to issuance of a development permit and before construction or development begins.

<u>Section 2</u>. <u>Severability</u>. Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

**Section 3.** Effective Date. This ordinance shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.





AN ORDINANCE repealing Ordinance 2960 and replacing it with this Ordinance which is Vacating a portion of Lightning Way, a public right-of-way in the City of Union Gap, Washington

WHEREAS, the City of Union Gap, pursuant to RCW 35.79.010, passed Resolution 18-65, which initiated the procedure for vacating a portion of the City of Union Gap right-of-way located on the real property described on Exhibit "A," and as depicted on "Exhibit B" (the "*Vacated Right-of-Way*"), both of which Exhibits are attached hereto and incorporated herein, and

WHEREAS, a public hearing was held pursuant to timely legal notice, which was provided by the Union Gap City Council, and the matter of vacating the Vacated Right-of-Way was considered by the Union Gap City Council on January 14, 2019, and

WHEREAS, the City Council of the City of Union Gap, Washington, has considered all matters presented at the public hearing on the proposed vacation and does hereby find that the vacation of the Vacated Right-of-Way is appropriate and that the transfer of property at issue in this matter is in best interest of the public.

WHEREAS, this Ordinance replaces Ordinance 2960 which Council approved on January 14<sup>th</sup>, 2019, and

WHEREAS, a draft version of the Ordinance was inadvertently included in the Council packet on January 14<sup>th</sup>. This draft which was passed as Ordinance 2960 had some errors contained in it that requires correction and thus this Ordinance corrects those errors, and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF UNION GAP DOES ORDAIN as follows:

Section 1. The Vacated Right-of-Way located on the real property described on the attached Exhibit "A" and depicted on attached Exhibit "B" is hereby vacated.

Section 2. As a condition to the passage of this ordinance, the property owner of Yakima County Assessor's tax parcel No. 191206-33416 shall convey the real property described on attached Exhibit "C" and depicted on attached Exhibit "B" for purposes of public right-of-way dedication (the "*Replacement Right-of-Way*"). This ordinance shall not be effective and recorded until the deed conveying the Replacement Right-of-Way has been recorded with the Yakima County Auditor.

Section 3. Nothing contained in this Ordinance serves to vacate that certain public utility easement lying along the west 25 feet of the Vacated Right-of-Way, as shown on Exhibit "B," and as appears on the face of the Short Plat recorded under Yakima County Auditor's File No. 7335606 for the construction, repair and maintenance of public utilities and services.

Section 4. Ordinance 2960 is hereby repealed and replaced in its entirety with this Ordinance.

Section 5. This ordinance shall be in full force and effect five (5) days after passage, as required by law, or five (5) days after the condition in section 2 is complete, whichever event occurs later. If the condition of vacation as stated in Section 2 is not completed within 120 days of the effective date of this Ordinance, this Ordinance shall be null and void.

Section 6. A certified copy of this ordinance shall be recorded by the Union Gap City Clerk with the Yakima County Auditor within ten (10) days of its effective date.





## Depiction of Beltway R/W, Tract A, and Tract B Dedication on Short Plat





PARTIES: AHTANUM GAP, LLC, a Washington limited liability company (referred to in this Agreement as "*Ahtanum Gap*")

### CITY OF UNION GAP,

a Washington municipal corporation (referred to in this Agreement as the "<u>City</u>")

**BACKGROUND.** On March 9, 2015, the City passed the below-described RBBA Ordinance for the purpose of funding part of the private funds needed to construct a portion of the below-described Regional Beltway. The portion of the Regional Beltway that runs south from Ahtanum Road and across Wide Hollow Creek to the now existing roundabout on West Rose Street has been constructed. The City intends to construct the remainder of the Regional Beltway in the next few years. Ahtanum Gap wishes to support the City's efforts to construct the remainder of the Regional Beltway and now enters into this Agreement for the purpose of (a) dedicating certain land needed for the construction of the remainder of the Regional Beltway and (b) prepaying funds under the RBBA Ordinance. In exchange for Ahtanum Gap is support and commitments under this Agreement, the City makes certain commitments to Ahtanum Gap in connection with certain land that lies within the Regional Beltway Benefit Area created under the RBBA Ordinance.

**AGREEMENT.** FOR GOOD AND VALUABLE CONSIDERATION, THE RECEIPT AND ADEQUACY HEREBY ACKNOWLEDGED, THE UNDERSIGNED PARTIES AGREE AS FOLLOWS:

- 1. **Definitions.** The following terms, when used in this Agreement, have the following meanings:
  - 1.1 "*AG BLA*" means the proposed short subdivision exemption boundary line adjustment as shown on attached <u>*Exhibit E*</u> for the purpose of merging Tract D and a portion of the to-be-vacated Existing North-South R/W into Lot 1 of the AG Short Plat property.
  - 1.2 "*AG Short Plat*" means the proposed Short Plat attached as <u>*Exhibit C*</u> for the subdivision of below-described Parcel 6.
  - 1.3 "*Beltway R/W*" means and refers to the Yakima County, Washington, real property depicted and labeled as the "125' *Public R/W*" on the AG Short Plat, which property will be used by the City for the location and construction of a portion of the Regional Beltway.
  - 1.4 "*Existing North-South R/W*" means and refers to the Yakima County, Washington, real property described and depicted as the "*Existing North-South R/W*" on the Right of Way Exhibit.
  - 1.5 "*Parcels 1-4*" means and refers to the Yakima County, Washington, property described as "*Parcel 1*," "*Parcel 2*," "*Parcel 3*," and "*Parcel 4*" on attached <u>Exhibit B</u>, which are commonly referred to as Yakima County Assessor Parcel Nos. 191206-33411, 191206-33412, 191206-33413, and 191206-33414 and are owned by Ahtanum Gap.

- 1.6 "*Parcels 5*" means and refers to the Yakima County, Washington, property described as "*Parcels 5*" on attached <u>*Exhibit B*</u>, which is commonly referred to as Yakima County Assessor Parcel No. 191206-33416 and is owned by Ahtanum Gap.
- 1.7 "*Parcel 6*" means and refers to the Yakima County, Washington, property described as "*Parcel 6*" on attached <u>*Exhibit B*</u>, which is commonly referred to as Yakima County Assessor Parcel No. 191206-33403 and is owned by Ahtanum Gap.
- 1.8 "*RBBA Ordinance*" means and refers to Ordinance No. 2871 for the City of Union Gap, Washington, a true and complete copy of which is attached as <u>*Exhibit F*</u>
- 1.9 "*Regional Beltway*" means and refers the roadway the City intends to construct from Longfibre Road to Main Street as generally depicted in the drawing attached as <u>*Exhibit A*</u>.
- 1.10 "*Replacement North-South R/W*" means and refers to the Yakima County, Washington, real property described and depicted as the "*Replacement North-South R/W*" on the Right of Way Exhibit.
- 1.11 "*Right of Way Exhibit*" means and refers to the Right of Way Exhibit attached as <u>Exhibit</u> <u>D</u>, which depicts Tract C, Tract D, the Existing North-South R/W, and the Replacement North-South R/W.
- 1.12 "*Tract A*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "A*"" on the AG Short Plat.
- 1.13 "*Tract B*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "B*"" on the AG Short Plat
- 1.14 "*Tract C*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract* "*C*"" on the Right of Way Exhibit.
- 1.15 "*Tract D*" means and refers to the Yakima County, Washington, real property described and depicted as "*Tract "D*"" on the Right of Way Exhibit.
- 2. <u>Vacation of Existing North-South R/W</u>. The City has approved the vacation of the Existing North-South R/W in accordance with the documentation attached as <u>Exhibit G</u>. Within *fourteen (14) business days* following the full execution of this Agreement, the documentation attached as <u>Exhibit G</u> will be fully executed and recorded by the City with the Yakima County Auditor for the purpose of vacating the Existing North-South R/W as set forth therein such that the west half of the Existing North-South R/W will be merged into Tract C and Parcel 5 and the east half of the Existing North-South R/W will be merged into Parcel 6.
- 3. <u>Replacement North-South R/W Dedication</u>. Within *fourteen (14) business days* following the full execution of this Agreement, (a) Ahtanum Gap will execute and deliver to the City the documentation attached as <u>Exhibit H</u> for the purpose of dedicating the Replacement North-South R/W to the City simultaneous with the recording of the Existing North-South R/W vacation documentation under Section 2 above and (b) the City will cause the documentation attached as <u>Exhibit H</u> to be recorded with the Yakima County Auditor.
- 4. <u>Recording of AG Short Plat</u>. The City has approved the AG Short Plat. Within *fourteen (14) business days* following the full execution of this Agreement, the mylar for the AG Short Plat will

be recorded by the City with the Yakima County Auditor for the purpose of subdividing Parcel 6 as set forth in the AG Short Plat.

- 5. Beltway R/W, Tract A, and Tract B Dedications. Within fourteen (14) business days following the full execution of this Agreement, (a) Ahtanum Gap will execute and deliver the documentation attached as <u>Exhibit I</u> for the purpose of dedicating the The Beltway R/W, Tract A, and Tract B properties to the City simultaneous with the recording of will be dedicated for public purposes on the face of the AG Short Plat, a copy of which is attached as <u>Exhibit I</u>, when the City records the AG Short Plat mylar under Section 4 above and (b) the City will cause the documentation attached as <u>Exhibit I</u> to be recorded with the Yakima County Auditor of this Agreement.
- 6. <u>**Recording of AG BLA.</u>** The City has approved the AG BLA. Within *fourteen (14) business days* following the full execution of this Agreement, the required documentation for the AG BLA will be recorded by the City with the Yakima County Auditor for the purpose of completing the AG BLA.</u>
- 7. **Regional Beltway Access Approaches.** The property included within the AG Shot Plat will be allowed *two (2) commercial access approaches* to and from the Regional Beltway that will allow both right and left turns in and out of said property to and from the Regional Beltway. The access approaches will be *thirty (30) feet* in width and otherwise standard in nature for City commercial access approaches. The exact location of the access approaches to and from the Regional Beltway for the property included within the AG Short Plat will be determined and approved by the City and the owner(s) of the property on which the access approaches will be located at the time of said property's development; *provided, however*, it is believed the access approaches will likely be established in the locations generally depicted and labeled as the "Access Points" in the drawing attached as <u>Exhibit J</u>.
- 8. <u>Construction of the North-South Roadway</u>. The City, at the City's expense and with no additional cost to Ahtanum Gap or the owners of any of the Parcels 1-4, Parcel 5, Parcel 6, or vacated Existing North-South R/W property, will fund and construct the north/south connector road through the Replacement North-South R/W for the purpose of connecting the Regional Beltway with West Pine Street when and at the same time the portion of the Regional Beltway that runs through the Beltway R/W is constructed. The City will not allow access approaches along this section of new roadway.
- 9. Wetlands. There are a collection of purported wetlands located on the Parcel 6 property in the approximate locations depicted and labeled as "Wetland 1," "Wetland 2," and "Wetland 3" on the drawing attached as <u>Exhibit K</u>. When the portion of the Regional Beltway that runs through the Beltway R/W is constructed, the City, at the City's expense and with no additional cost to Ahtanum Gap or the owners of any of the Parcels 1-4, Parcel 5, Parcel 6, or vacated Existing North-South R/W property, will mitigate and move off site to property owned by the City, "Wetland 1", "Wetland 2," and "Wetland 3" as generally depicted on the drawing attached as <u>Exhibit K</u>, with said Wetlands to be relocated -consistent with the conceptual mitigation plan as approved by the State of Washington Department of Ecology, dated January 20, 2016. in accordance with applicable law.
- 10. Beltway Fee Payment. In light of Ahtanum Gap's agreement hereunder to dedicate the Beltway R/W, Tract A, Tract B, and Replacement North-South R/W property to the City and Ahtanum Gap's agreement hereunder to prepay the Regional Beltway fee authorized under the RBBA Ordinance that is assessed against the Parcels 1-4, Parcel 5, and Parcel 6 property, the City agrees to reduce and fix the fee assessed under the RBBA Ordinance against the Parcels 1-4, Parcel 5, and

# Parcel 6 property at One Hundred Sixty-Four Thousand Four Hundred Forty-Four and No/100 U.S. Dollars (\$164,444.00) (the "<u>RBBA Assessment</u>").

Ahtanum Gap will pay the full RBBA Assessment to the City within *three (3) business days* of the completion of the recording of the documentation for the vacation of the Existing North-South R/W, finalization of the AG Short Plat, and finalization of the AG BLA under Sections 2, 5, and 6 above. The RBBA Assessment, once paid by Ahtanum Gap to the City, will satisfy all assessments now and in the future due under the RBBA Ordinance and any and all existing and future amendments, modifications, and supplements thereof (including, without limitation, any new or additional ordinances or other laws or assessments passed in the future for the purpose of funding the construction of any portion of the Regional Beltway) for the property that comprises the Parcels 1-4, Parcel 5, Parcel 6, and vacated Existing North-South R/W property.

Subject to the terms of this Agreement, the property that comprises the Parcels 1-4, Parcel 5, Parcel 6, and vacated Existing North-South R/W property will be subject to City of Union Gap development requirements at the time of development.

#### 11. Representations and Warranties.

- 11.1 *Ahtanum Gap Authorization.* Ahtanum Gap represents and warrants to the City that (a) Ahtanum Gap has full power and authority to enter into this Agreement; and (b) this Agreement, when executed and delivered by Ahtanum Gap's below-stated Manager, will constitute valid and legally binding obligations of Ahtanum Gap enforceable in accordance with their terms hereof.
- 11.2 *City Authorization.* The City represents and warrants to Ahtanum Gap that (a) the City has full power and authority to enter into this Agreement; and (b) this Agreement, when executed and delivered by the City's below-stated Mayor, will constitute valid and legally binding obligations of the City enforceable in accordance with their terms hereof.
- 12. <u>Binding Effect; Covenants Running with the Land</u>. The provisions of this Agreement are binding on the undersigned parties and their respective heirs, successors, and assigns and constitute covenants and benefits appurtenant to and running with Parcels 1-4, Parcel 5, and Parcel 6 property.
- 13. <u>Memorandum of Agreement</u>. The undersigned parties will not record this Agreement. However, within *fourteen (14) business days* following the full execution of this Agreement, the undersigned parties will execute the Memorandum of Agreement attached as <u>Exhibit L</u> and record said Memorandum with the Yakima County Auditor for the purpose of providing public notice of the existence of this Agreement.

#### 14. General Terms.

- 14.1 *Exhibits.* There are no exhibits or other attachments to this Agreement except for the exhibits expressly referenced in this Agreement, each of which constitutes a part of this Agreement as if set forth in full herein.
- 14.2 *Amendment.* This Agreement may be amended only by the signed written agreement of each of the parties to this Agreement.
- 14.3 **Binding Effect.** All of the provisions of this Agreement will inure to the benefit of and be binding on the successors and assigns of each of the parties to this Agreement.

- 14.4 *Time is of the Essence.* Time is of the essence as to all terms of this Agreement.
- 14.5 *Independent Contractors.* The parties to this Agreement are and will remain contractors independent of each other with respect to the subject matter of this Agreement.
- 14.6 **Construction and Headings.** The captions and paragraph headings used in this Agreement are inserted for convenience of reference only and are not intended to define, limit, or otherwise affect the interpretation or construction of any provision of this Agreement.
- 14.7 *Waivers.* Any party to this Agreement may waive any obligation under this Agreement of the other party to this Agreement, but only if the waiver is made in writing by the waiving party. However, no such waiver will constitute a further or continuing waiver of any preceding or succeeding default of the same or any other obligation under this Agreement.
- 14.8 *Cumulative Remedies.* No remedy made available under this Agreement or otherwise by law is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy given under this Agreement or now or hereafter existing at law or in equity or by statute or otherwise.
- 14.9 **Specific Performance/Injunctive Relief.** Each party's obligations under this Agreement are unique. If any party should default in its obligations under this Agreement, the parties acknowledge it would be extremely impracticable to measure the resulting damages. Accordingly, the nondefaulting party, in addition to any other rights or remedies available under this Agreement or otherwise by law, may sue in equity for specific performance and/or injunctive relief, and the parties each expressly waive the defense that a remedy in damages will be adequate.
- 14.10 *Governing Law; Venue.* This Agreement will be interpreted and construed under and governed by the state laws of the State of Washington and federal laws of the United States of America. The exclusive venue for any legal action concerning this Agreement will be the Yakima County Superior Court for the State of Washington and the undersigned parties hereby submit to the jurisdiction thereof.
- 14.11 *Attorneys' Fees and Costs.* If any party to this Agreement brings a legal action to interpret or enforce this Agreement, the substantially prevailing party in the action will be entitled to an award of the legal costs and reasonable attorneys' fees said party incurs in the action, whether in arbitration, at trial, on appeal, or in a bankruptcy proceeding.
- 14.12 *Further Assurances.* In addition to the instruments to be delivered as provided in this Agreement (if any), each party to this Agreement, from time to time at the request of the other party to this Agreement, will execute and deliver to the requesting party such other instruments, and will use commercially reasonable efforts to take such other action, as may be necessary or proper to more effectively carry out the intent and provisions of this Agreement.
- 14.13 **Severability.** If any provision of this Agreement is determined to be invalid or unenforceable, that provision and the remainder of this Agreement will continue in effect and be enforceable to the fullest extent permitted by law. Furthermore, it is the intention of the parties to this Agreement that if any provision of this Agreement is capable of two constructions, one of which would render the provision void, and the other of which would

render the provision valid, then the provision will have the meaning that renders the provision valid.

- 14.14 *Entire Agreement.* This Agreement (including all recitals, background information, and defined terms) constitutes the entire understanding and agreement of the parties to this Agreement with respect to its subject matter. All prior agreements, understandings, or representations with respect to this Agreement's subject matter (if any) are hereby canceled in their entirety and are of no further force or effect. It is expressly acknowledged that there are no oral or other agreements which modify or affect this Agreement.
- 14.15 *Counterparts and Copies.* This Agreement may be executed in any number of identical counterparts, with each counterpart having the same effect as if all parties to this Agreement had signed the same document. All executed counterparts of this Agreement will be construed as and constitute one and the same instrument. A facsimile or electronic copy (*e.g.*, a PDF copy) of an executed counterpart of this Agreement will have the same effect as an original executed counterpart of this Agreement.
- 14.16 *Warranty of Authority*. Each of the individuals signing this Agreement on behalf of a party to this Agreement warrants and represents that such individual is duly authorized and empowered to enter into this Agreement and bind such party hereto.

#### INTERGOVERNMENTAL LOCAL AGREEMENT FOR STORMWATER PERMIT COMPLIANCE ACTIVITIES BETWEEN YAKIMA COUNTY AND THE CITIES OF SELAH, UNION GAP AND SUNNYSIDE

THIS AGREEMENT is made and entered into between Yakima County, a municipal corporation of the State of Washington, hereinafter referred to as "County", and the Cities of Selah, Union Gap and Sunnyside, all being municipal corporations, hereinafter referred to as "Selah", "Union Gap" and "Sunnyside" respectively, or "Cities" when it includes all, or "City" when it is either Selah, Union Gap or Sunnyside; and,

WHEREAS, the County and Cities have authority to operate and maintain storm and surface water management systems and many other services as provided for under their relevant laws; and,

WHEREAS, Yakima County and the Cities of Selah, Union Gap and Sunnyside are required to comply with the State of Washington's Eastern Washington Phase II Municipal Stormwater General Permit, hereinafter referred to as the "Permit"; and,

WHEREAS, the County and Cities under the Permit have been encouraged to coordinate; and,

WHEREAS, the County and Cities acknowledge the benefits of a voluntary, ad hoc regional group, as allowed under the Permit; and,

WHEREAS, the County and Cities formed the Regional Stormwater Working Group (RSWG) in order to provide the best value and service for their citizens concerning the development of a regional stormwater plan to satisfy the Permit for their respective Municipal Separate Storm Sewer Systems (MS4s); and,

WHEREAS, the County and Cities under RCW Chapter 39.34, have the legal authority to enter into interlocal agreements for the sewerage and stormwater management programs within its boundaries consistent with relevant laws; and,

WHEREAS, under this interlocal agreement, the County and Cities agree to obtain and hold their own separate municipal stormwater permits and are responsible for performing all duties to comply with the standards of the Permit, as required by the Permit; and,

WHEREAS, the County and the Cities would like to continue the RSWG as outlined in this agreement for public benefit and for the protection of the quality of surface waters and ground waters of the state by managing the discharge of stormwater through their respective MS4s; and,

NOW, THEREFORE, in consideration of the covenants and agreements to be kept and performed by the parties hereto, it is agreed as follows:

#### Section 1. Definition of Terms

Wherever the following terms are used in this agreement they shall have the following meaning unless otherwise specifically indicated by the context in which they appear:

- A. <u>Area of Geographic Responsibility</u> The Areas of Geographic Responsibility for the Cities and County are as described in Section S1. of the Permit. For the Cities, this means the entire incorporated area of the City as they exist at the time of execution of this ILA and as they may be amended during the existence of this Agreement. For the County, this means the urbanized areas and the unincorporated urban growth areas associated with permitted Cities within the urbanized areas that are under the jurisdictional control of the County. This geographic area of coverage also includes any urban growth areas that are contiguous to permitted urbanized areas that are under the jurisdictional control of the County.
- B. <u>BMP</u> means Best Management Practice and may include, but is not limited to, a schedule of activity, prohibition of practice, maintenance procedure, and structural and/or managerial practice that, when used singly or in combination, prevents or reduces the release of pollutants and other adverse impacts to receiving waters.
- C. Board or BOCC means the Board of Yakima County Commissioners, its governing body.
- D. <u>Capital Improvement Project (CIP)</u> is a constructed project facility such as a road improvement or stormwater control facility that is generally of a durable nature.
- E. <u>Chief Executive Officer</u> (CEO) means the designated City official responsible for managing the day-to-day business affairs of City. This is either the City Manager for Council-Manager or Mayor for Mayor-Council city government.
- F. Council means the City Council, governing body of a City.
- G. Ecology means the Washington State Department of Ecology.
- H. <u>Monthly Service Charge</u> means the monthly portion of the annual costs distributed between the Parties and paid to the County to perform tasks identified in this Agreement.
- <u>Municipal Separate Storm Sewer System (MS4)</u> means a conveyance, or system of conveyances (including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, manmade channels, or storm drains) owned or operated by the Parties that is designed or used for collecting or conveying stormwater; which is not a combined sewer; and which is not part of a sanitary sewer.
- J. <u>Operation and Maintenance (O&M)</u> means the regular performance of work and corrective measures taken to repair facilities.
- K. <u>Person</u> means the State of Washington, any individual, public or private corporation, political subdivision, governmental agency, municipality, industry, co-partnership, association, firm, trust, estate or any other legal entity whatsoever.
- L. <u>Party (ies)</u> means the individual or collective members of this Interlocal Agreement: Yakima County, City of Selah, City of Union Gap, City of Sunnyside.
- M. <u>Public Services Director</u> means the designated County official responsible for managing the RSWG business affairs for Yakima County.

- N. <u>Regional Stormwater Working Group (RSWG)</u> is an organization formed consisting of representatives from the Parties whose main purpose is to review and make recommendations on regional stormwater policies required under the Permit, as well as to assist in dispute resolution between the Parties.
- O. <u>Service Rate</u> is a rate billed to residents and businesses within a Party's jurisdiction to support their stormwater program.
- P. <u>Systems Development Charge</u> is a rate billed to applicants within a Party's jurisdiction proposing construction or development activities to cover the cost of review and approval of the applicant's project to ensure compliance with the Permit.
- Q. <u>Total Maximum Daily Load (TMDL)</u> means a site-specific allocation of water-borne pollutants from all sources to a particular receiving water to comply with the State's surface water quality criteria.
- R. <u>Underground Injection Control (UIC)</u> means a well that is a manmade subsurface fluid distribution system designed to discharge fluids into the ground and consists of an assemblage of perforated pipes, drain tiles, or similar mechanisms, or a dug hole that is deeper than the largest surface dimension (WAC 173-21-030). UIC systems include drywells, pipe or French drains, drain fields, and other similar devices that are used to discharge stormwater directly into the ground.

Section 2. Transfer of Responsibility

A. Purpose. The purpose for this Agreement is for the Cities and County to coordinate and collaborate on certain responsibilities of the Permit as specified in this document. The responsibilities of the Parties are defined in this Section, Section 3, Section 6 and in Section S3 of the Permit.

B. Limitations. The ownership and maintenance of facilities remains the responsibility of the Parties within their respective jurisdictions. The following stormwater program items for each Party, are not covered under this Agreement and are not included in the estimated program costs:

- Stormwater Equipment Funding
- CIP Funding
- Program Funding Mechanism
- Stormwater Program Reserve Funding
- UIC Program requirements of Chapter 173-218 WAC
- C. Division of Responsibilities
  - 1. County will administer portions of this Agreement in Sections 3, 5.A.1, and 5.A.2 with the Cities maintaining specific functions, as defined in Section 2B and 3.
  - 2. Each Party is responsible for funding the program activities to support the Permit within their respective jurisdiction, including those activities defined by this Agreement.
  - 3. Each Party will provide those items and activities necessary to run their respective program and maintain compliance in accordance with the Permit schedule, including but not limited to annual reporting requirements, public education and outreach, mapping of the respective

stormwater systems, MS4 O&M, illicit discharge detection and elimination, and effectiveness assessment.

4. During the term of this Agreement, Parties will operate and maintain all stormwater facilities at the level specified in the Permit and in order to retain Permit compliance.

#### Section 3. Representation with the EWSG

A. Participation in this agreement means that the Parties also acknowledge the existence and purpose of the Eastern Washington Stormwater Group (EWSG). The EWSG is an ad hoc, voluntary group of municipal stormwater permittees formed to share knowledge and collaborate in the implementation of the Permit in Eastern Washington and consult with Ecology on Eastern Washington needs and requirements. Since 2007, the County has taken the lead role in representing the RSWG members by attending regular EWSG meetings and disseminating information back and forth between the two groups.

B. Participation in this agreement means that the Parties agree that the County will continue in its lead role of representing the RSWG at the EWSG. Cities can choose to directly participate in the EWSG at any time by notifying the County and the Chair of the EWSG in writing and in advance of any regular meeting. , The County will withdraw representation of any City in any future EWSG meeting or vote upon written notification.

#### Section 4. Additional Party Responsibilities

- A. In order for the Parties to fulfill the requirements of the Permit, it is anticipated that the County will occasionally require access to the Cities' MS4 and vice versa. Cities will allow the County access at any reasonable time upon reasonable notice to facilitate permit compliance within the City and the City Area of Geographic Responsibility. Likewise, the County will allow the Cities access at any reasonable time upon reasonable notice to facilitate permit compliance.
- B. The Parties will participate in the RSWG on a voluntary basis to coordinate the regional stormwater quality effort. The RSWG shall meet as desired by the Parties, to discuss status of permit compliance and address any issues related to compliance with the Permit or this interlocal agreement.
- C. UIC Program. Where UICs are a part of the public MS4, the Parties will manage them and report their activities in accordance with the Underground Injection Control (UIC) program as described in Chapter 173-218 WAC.
- D. Parties will perform operation and maintenance or CIP within their area of geographic responsibility when permit activities indicate a permit violation.
- E. Parties may use existing and future equipment sharing agreements when possible to keep stormwater O&M costs down.

#### Section 5. Determination of Costs; Operating Procedures and Rules Relating to Expenses

- A. Determination of Costs and Division of Expenses
  - 1. Unless otherwise identified, the expenses incurred by the County to complete RSWG and ESWG tasks to fulfill this agreement will be distributed on the following percentage basis, as agreed to by the Parties and based on relative numbers of households in each community:
    - Yakima County 51%
    - City of Selah 13%
    - City of Union Gap 14%
    - City of Sunnyside 22%
  - 2. Upon request, some tasks identified in this agreement will be billed on a case by case basis to a specific City or Cities, such as: construction plan review, post-construction plan review, illicit discharge investigation, and specific training events outside the scope of this agreement. These activities must be requested in writing by the City, acknowledged by the County, and will be billed at actual County wages with fringe benefits and overhead.
  - 3. The distribution of costs will remain fixed for the duration of this agreement, per Section 5.A.1 above. In the event one or more of the Parties withdraws from this Agreement, the Parties shall update said Section.
  - The County will bill for its services monthly for actual wages and benefits expenditure basis plus overhead.
  - 5. In the event a Party withdraws from or is for any reason removed from this Agreement, then that Party shall be financially responsible for the actual percentage of that Party's total annual costs that have been expended or obligated under the Agreement on that Party's behalf as of the date of withdrawal or removal. A Party's unpaid obligations or overpayments under this subsection shall be fully compensated to the appropriate Party within forty five (45) days of the withdrawal or removal. The County's financial records for this Agreement shall be relied upon for determinations required under this subsection.
- B. Operating Procedures Relating to Expenses
  - 1. The County shall establish separate accounting codes for the purpose of tracking all expenses and service charges pursuant to the Agreement.
  - 2. The Parties may at any reasonable time upon reasonable notice inspect and audit the books and records of the County with respect to matters within the purview of the Agreement.
  - 3. The Cities shall pay the monthly service charge to the County no later than the 15<sup>th</sup> day of each month.
  - 4. Payments from Cities to the County overdue by sixty (60) days will be considered late.
  - 5. Interest may accrue on late monthly payments to the County as specified in Section 5.B.4 of this Agreement at a rate of 1.25 times the monthly Local Government

Investment Pool (LGIP) earnings rate as posted for the previous month, and will be applied each month to the unpaid balance.

C. The Cities and the County will be billed separately by Ecology for their perspective stormwater permit fees at the standard Ecology Stormwater Permit rate for that municipality or jurisdiction. Each Party will be responsible for the payment of their own Ecology Stormwater Permit fee according to the requirements stipulated in the Permit.

#### Section 6. Administrative and Operating Provisions

- A. Insurance. Each Party is responsible for securing and keeping in full force and effect for the term of this agreement, at its own expense, comprehensive general liability insurance; or if self-insuring shall maintain insurance sufficient to indemnify and defend the injured party against claims for personal injury or death and property damage arising out of the actions of the responsible party, its contractors, employees and agents determined to be responsible for the injury. The Parties shall be responsible only for losses attributable to the sole negligence or intentional conduct of their agency, its elected or appointed officers, officials, employees, agents, contractors or sub-contractors. Each party that performs activities pursuant to this agreement shall maintain worker's compensation insurance, as required by state and federal statute, for its employees engaged in work on the Premises. If such work is contracted, County shall require that all contractors provide worker's compensation insurance for all their employees engaged in work on the Premises. If any class of employees engaged in work on the Premises is not covered under workers' compensation insurance, the contracting party shall cause each contractor to maintain liability insurance for limits of at least \$2,000,000 for each incident, or \$5,000,000 per incident, for injuries caused by accident or negligence.
- B. Indemnification. The parties hereby indemnify and holds harmless each other and those with legal right to enter upon the premises and will defend against any and all demands, claims, suits, risks, liabilities and obligations of any nature and any and all costs or expenses of any nature including, but not limited to, all losses, damages, judgments and reasonable attorney's fees arising from injury to or death of any and all persons and/or all property damage of any kind, whether tangible or intangible, including loss of use, in connection with or related to the construction or excavation performed under this agreement, except only those losses resulting solely from the negligence or willful misconduct of the responsible party, its employees or tenants or guests and agents. Each party's obligation hereunder is without prejudice to the other's rights to assert all defenses they may have against any claimant and the right to seek contribution from any other person or entity which may be responsible for all or any portion of the alleged claim. The Party receiving notice of a claim shall notify each of the other parties to the agreement of any claim as to which that party has the obligation to indemnify the other parties under this Agreement and each Party shall, at its sole cost and expense, defend the other parties against such claim. The defending party's defense shall include, but not be limited to, appearing and defending against any lawsuit and paying any amounts required to be paid pursuant to any judgment or settlement. Each party hereby further indemnifies and holds the other parties and its agents and guests, tenants and visitors from and against any and all demands, claims, suits, risks, liabilities, and obligations of any nature and any and all costs or expenses of any nature, including but not limited to, all losses, damages, judgments and attorney's fees arising from any breach or default in the performance of any obligation to be performed by that party or any assignee of the responsible party under the terms of this Agreement. Notwithstanding the above, if a court determines that this Agreement is subject

to the terms of RCW 4.24.115, in the event of liability for damages arising out of bodily injury to persons or damages to property caused by or resulting from the concurrent negligence of any of the parties and its agents and subcontractors, its commissioners, officers, employees or agents, that party's liability under this Paragraph shall be limited to the extent of the responsible party's negligence and that of its agents, employees, contractors, and assignees, including their proportional share of costs, reasonable attorney's fees, and expenses incurred in connection with any claim, action, or proceeding brought with respect to such injury or damage.

- C. Notice of Violation or Fine. All Parties acknowledge that they may receive notices of violations or fines from state or federal agencies for violations of state of federal rules imposed under the Permit. All Parties acknowledge that this agreement implies no shared responsibility for these violations and fines unless otherwise specifically noted by the state or federal agency. The County shall invite the responsible jurisdictions to participate in any discussions with state and federal agencies regarding notices of violation or fines involving jurisdictions actions or responsibility. All Parties acknowledge that they are singularly responsible for complying with all notices of violations and the payment of any fines involving their jurisdiction as a result of these notices or the failure to respond in a timely manner to the notices from a state or federal agencies. If more than one Party is responsible, each responsibility and degree of fault of each responsible City. Disputes over the amount a Party is responsible for shall be resolved by the dispute resolution process set out in Section 7 of this Agreement.
- D. Delegation. Nothing in this Agreement shall be construed as a limitation upon or delegation of the statutory and home rule powers of any City participating in this Agreement, nor as a delegation or limitation of the statutory powers of County. This Agreement shall not limit any right or remedy available to Cities or County against third parties arising from illegal acts of such third parties.

#### Section 7, Dispute Resolution; Remedies

- A. In the event of a dispute between the Parties regarding their respective rights and obligations pursuant to this Agreement, the disputing Parties shall first attempt to resolve the dispute by negotiation. If a dispute is not resolved by negotiation, the exclusive dispute resolution process to be utilized by the Parties shall be as follows:
  - 1. Step 1. Upon failure of those individuals designated by each Party to negotiate on its behalf to reach an agreement or resolve a dispute, the nature of the dispute shall be put in writing and submitted to City's CEO and the County Public Services Director, who shall meet and attempt to resolve the issue. If the issue in dispute is resolved at this step, there shall be a written determination of such resolution, signed by City's CEO and the County Public Services Director, which determination shall be binding on the parties. Resolution of an issue at this step requires concurrence of both parties' representative. If not resolved in thirty (30) days, this issue may be taken to Step 2.
  - 2. Step 2. Upon failure of the City's CEO and the County Public Services Director to negotiate on its behalf to reach an agreement or resolve a dispute as provided in Step 1, the nature of the dispute shall be put in writing and submitted to the respective officials of the RSWG, who shall meet and attempt to resolve the issue. If the issue in dispute is resolved at this step, there shall be a written determination of such resolution, signed by City's CEO

and the County Public Services Director, which determination shall be binding on the parties. Resolution of an issue at this step requires concurrence of both parties' representatives. If not resolved in thirty (30) days, this issue may be taken to Step 3.

- 3. Step 3. In the event a dispute cannot be resolved at Step 2, the Parties shall submit the matter to mediation. The Parties shall attempt to agree on a mediator. In the event they cannot agree, the Parties shall request a list of five (5) mediators for the American Arbitration Association, or such other entity or firm providing mediation services to which the Parties may further agree. Unless the disputing Parties can mutually agree to one mediator from the list provided, each Party shall strike a name in turn, until only one name remains. The order of striking names shall be determined by lot. Any common costs of mediation shall be borne equally by the disputing Parties, who shall each bear their own costs thereof. If the issue is resolved at this step, a written determination of such resolution shall be signed by both Parties. Resolution of an issue at this step requires concurrence by both Parties.
- Step 4. If any dispute is not settled in Step 3, either Party may request binding arbitration. 3. The Parties shall agree, within ten (10) days of the completion of Step 3, on an arbitrator who shall be an attorney licensed to practice law in Washington (or a retired attorney) or a retired Washington judge, to resolve the dispute. If they are unable to agree on an arbitrator within ten (10) days, then each Party shall appoint an arbitrator. The two arbitrators shall choose a third. If the choice of the second or third arbitrator is not made within ten (10) days of the choosing of the prior arbitrator, then either Party may apply to the presiding judge of the judicial district of Yakima County to appoint the required arbitrator. The arbitrator(s) shall proceed according to the Washington statutes governing arbitration, and the award of the arbitrator(s) shall have the effect therein provided. The arbitration shall take place in Yakima County. Costs of a single or any third arbitrator shall be shared equally by the Parties. Each Party shall pay their own arbitrator. The arbitrators may allow discovery, as provided by Washington law and may grant any remedy or relief which the arbitrator(s) deem just and equitable and within the scope of the agreement of the Parties, including, but not limited to, specific performance of any obligation created under the agreement, any interim or provisional relief that is necessary to protect the rights or property of the Parties, or imposition of sanctions for abuse or frustrations of the arbitration process.
- B. Parties may mutually agree in writing to waive any of the above steps, or to enter into alternate processes or additional processes.

#### Section 8. Attorney Fees

In the event any Party shall institute arbitration as set forth in this Agreement (or any other dispute resolution proceeding) against any other Party to this Agreement, in any way arising out of, connected with or relating to this Agreement, the prevailing Party in that arbitration (or any other dispute resolution proceeding) shall be entitled to recover, in addition to all other appropriate relief, the prevailing Party's costs and reasonable attorney fees incurred in that arbitration (or any other dispute resolution proceeding), said amount to be set by the arbitrator (or courts) before which the matter is tried, heard or decided.

#### Section 9. Modifications or Amendments

No amendment, change or modification to this Agreement shall be valid, unless in writing and adopted and signed by all the Parties hereto.

#### Section 10. Final Agreement/Merger

This Agreement contains the final and entire agreement between the Parties and is entered into with the understanding that all prior discussions, representations and agreements are merged into this Intergovernmental Agreement.

#### Section 11. Duration

This Agreement is effective until the permit expiration date of July 31, 2024. Amendment and/or extension of this ILA for the next Permit cycle shall occur no later than six (6) months before current permit expiration date, or January 31, 2024.

#### Section 12. Termination

Parties may terminate their obligations under this Agreement for the reasons listed below. The Permit requires that permittees notify Ecology of any/all amendment or termination actions.

- A. If a Party materially defaults in the terms of this Agreement and such default continues for a period of more than thirty (30) days after written notice from the Public Services Director to the defaulting Party specifying the nature of the default. If the default cannot reasonably be cured within thirty (30) days, such default shall be a material breach if the breaching Party fails within thirty (30) days of written notice to commence and pursue curative action with reasonable diligence. One Party's termination by default does not constitute termination of the Agreement by the remaining Parties. This Agreement will be modified to define financial obligation of the remaining Parties.
- B. If the provisions of this Agreement become impracticable due to a change in the law or other changed circumstances, which did not exist at the time of the signing of this Agreement.
- C. Any Party may withdraw from the Agreement upon thirty (30) days written notice to the other Parties. Withdrawal of one Party does not constitute termination of the Agreement by the remaining Parties. In the event of a Party's withdrawal this Agreement will be modified to define the financial obligations of the remaining Parties.

#### Section 13. Language; Headings

Where the context so requires the singular shall be deemed to include the plural, the plural the singular, and the masculine, feminine or neutral to mean the other. The paragraph captions shall not be used to construe or interpret this Agreement.

#### Section 14. Drafting; Construction

Each Party intends that this Agreement in all respects shall be deemed and construed to be equally and mutually prepared by all Parties and it is hereby expressly agreed that any uncertainty or ambiguity shall not be construed for or against any Party.

#### Section 15. Severability

If any provision of this Agreement shall be invalid or unenforceable in any respect for any reason, the validity and enforceability or any such provision in any other respect and of the remaining provisions of this Agreement shall not be in any way impaired.

#### Section 16. Effective Date / Counterparts

This Agreement may be signed in counterparts, with each Party hereto receiving copies of all participating Party's fully executed signature pages. This Agreement shall become effective when executed by all Parties hereto.
