UNION GAP TOURISM WINS THE AWARD FOR OUTSTANDING MARKETING PROGRAM OR CAMPAIGN DURING THE INAUGURAL STATE OF WASHINGTON TOURISM AWARDS.

The State of Washington Tourism inaugurated a new award program last week at its October conference, conferring recognitions for Outstanding Marketing Campaign, Rising Star in Tourism, and Destination Stewardship. Three industry veterans were also inducted into the new Tourism Hall of Leadership. The awards and inductions were announced at the State of Washington Tourism Conference on October 11-12 at the Hilton Seattle Airport & Conference Center. Approximately 325 industry professionals from across the state attended. The conference opened with a video message from Governor Jay Inslee and featured a keynote address by popular public television host and travel guidebook author Rick Steves.

The award for Outstanding Marketing Program or Campaign was presented to Union Gap Tourism for its #SmallTownTourismChat campaign. Eric Patrick, the marketing and tourism director, accepted on behalf of the organization. The campaign is described as a fast and furious 30-minute chat about tourism in small towns that has quickly attracted the attention of additional communities, travel writers and local stakeholders. The campaign was also noted for its collaborations around the state and across the country. The #SmallTownTourismChat is on Twitter, and occurs at least once a month, typically on the 3rd Wednesday of each month at 2:30pnm PST. Occasionally 'bonus' chats occur, such as on Tuesday, November 1st when Union Gap Tourism was hosting two travel writers and did a live chat from For Heaven's Cake on Main Street.



SNOW REMOVAL

Resident cooperation is essential to the success of the snow removal operations. It is very important that vehicles are removed from City Right-of-Way when there is significant snowfall. With fewer cars on the streets, snow plows can do a more efficient job of clearing snow and ice.

As a reminder, UG Ordinance No. 2850 states in part: Snow and Ice Obstructions -No person shall cause snow or ice to be placed in any public street, alley, sidewalk or public way; provided, that this section shall not apply to Union Gap town employees performing the regular course of their duties. Violation of this section shall be a civil non-traffic infraction with a penalty of two hundred fifty dollars (\$250.00).

Dear Property Owner or Business Owner:

The Regional Wellhead Protection Committee (RWPC) was formed by eight (8) water purveyors in the Upper Yakima Valley, including the City of Union Gap in 1996 in response to Washington State Department of Health (DOH) wellhead protection planning requirements. The RWPC and the City are taking a proactive approach to wellhead protection planning to ensure that each community's groundwater supplies are adequately protected from potential contamination sources on the ground surface. The purpose of this letter is to notify you of the location of your business within one of the City's wellhead protection area and provide you with information on how you can help protect the City's drinking water supplies.

Wellhead protection planning includes four (4) elements:

- Development of wellhead protection area, or areas, which may be susceptible to contamination.
- Identification of potential contamination sources, which include septic tanks, underground storage tanks, abandoned wells, and certain businesses.
- Coordination of management efforts to help minimize the impact of potential contamination sources, including posting of signs, distribution of literature, and public education efforts.
- Development of contingency planning to ensure that prompt response procedures are in place in the event a well becomes contaminated.

The RWPC and the City understand that most business owners recognize the need to protect the environment in and around your business. We hope that informing you of your location of business within the City's wellhead protection area will result in an increase in precautions to ensure your activities do not adversely impact our drinking water supply. The following practices can greatly reduce the threat of contamination to groundwater supplies:

- Recycle all hazardous wastes used on the premises, including solvents, paints, cleaners, printing supplies, or other chemicals through Yakima County's free small quantity generator or recycling programs at 509.574.2450.
- Reduce the amount of hazardous waste used through waste minimization efforts. Free literature on waste minimization is available from the Department of Ecology (DOE) and Union Gap Public Works Administration Office at 509.225.3524.
- Conserve water whenever possible. Water conservation reduces waste volumes and reduces the threat of contaminant transport.

*After normal business hours, week-ends, and holidays the Police Department transfers their business line to SUNCOMM Communications - the 911 call center for Yakima County and dispatch for the Union Gap and Yakima Police Departments. If you do not get an answer right away, there is a good chance 911 is handling calls on their emergency lines and are unable to get to the non-emergency lines as quickly as normal.
