Vendors are requested to bring weights to anchor their booth and/or canopy. It is suggested that the weight be a 24" length of PVC approx. 2" to 2-1/2", filled with sand, capped at each end, with a hook attached, to fasten to each upright of the canopy framework. Labor & Industries laws and Health Department rules apply to all vendors. Each vendor is responsible for set-up, take down and clean-up of their own space. Please have booths removed and space cleaned **no later than 6:00 P.M. on the closing event day.** Vendors will be able to set up by 7 am on Saturday and security will be provided overnight on Saturday.
