# UNION GAP LIBRARY & COMMUNITY CENTER

### CHRISTMAS TREE PICKUP

### **YARD WASTE PICKUP**

The Public Works Department will pick up your bagged yard waste, weighing less than 40 lbs until March 1st.

### **SNOW REMOVAL**

Resident cooperation is essential to the success of the snow removal operations. It is very important that vehicles are removed from City Right-of-Way when there is significant snowfall. With fewer cars on the streets, snow plows can do a more efficient job of clearing snow and ice.

As a reminder, UG Ordinance No. 2850 states in part: Snow and Ice Obstructions - No person shall cause snow or ice to be placed in any public street, alley, sidewalk or public way; provided, that this section shall not apply to Union Gap town employees performing the regular course of their duties. Violation of this section shall be a civil non-traffic infraction with a penalty of two hundred fifty dollars (\$250.00).

### **IS YOUR DOG LICENSED?**

Section 6.04.110 of the Union Gap Municipal Code states the following:

All dogs three (3) months of age or older are required to be licensed under this chapter.

- a. Tags. The police department shall issue animal licenses consisting of a metal tag with a number corresponding to the number of the application to the applicant. The applicant is required to cause the tag to be attached or fixed to the animal. The tag is not transferable. The absence of the license tag on a dog's collar shall be prima facie evidence that said dog has not been legally licensed.
- b. Fees. The following fees shall be paid for licenses required under this chapter:
  - Spayed or neutered dogs that have current vaccinations and with a veterinarian's certificate: ten dollars (\$10.00) annually.
  - 2. Un-spayed, unneutered, or unvaccinated dogs, or dogs not current on vaccinations: thirty dollars (\$30.00) annually.
  - Licenses shall be valid from January 1st to the following December 31st. For
    other than first time owners of a specific dog, licenses purchased after April
    30th of any year shall be subject to an additional fee of fifteen dollars (\$15.00)
    for each license.

### **DIGGING ON YOUR PROPERTY?**

Are you planting a tree, installing a mailbox, building a deck or other projects that require digging? Before you dig, please remember to call the National "Call-Before-You-Dig" phone number *lit is required by law)*. Two or three days before you plan to break ground, dial 8-1-1 or make an online request at **www.callbeforeyoudig.org**. "Call-Before-You-Dig" Center will notify all affected utility operators of the need to mark any buried utility lines, in the area which you will be digging. You will see paint or flags marking the areas that utilities have been located; so you don't unintentionally dig into an underground line. Below are some color markings you may see:

WHITE
PINK
RED
YELLOW
ORANGE
BLUE
PURPLE
GREEN

Pre-marking of the outer limits of the proposed excavation or marking the centerline and width of proposed lineal installations of buried facilities.

Temporary Survey Markings.

Electric power lines, cables or conduit, and lighting cables. Gas, oil, steam, petroleum, or gaseous materials.

Communication, alarm, signal lines, cables or conduits, and fiber.
Potable water.

Slurry, irrigation and reclaimed water.
Sewers, drainage facilities or other drain lines.

### SIGHT OBSTRUCTIONS

Public Works Crews will be addressing properties that have sight obstructions. Sight obstructions include trees, bushes, etc. which have been allowed to grow in a manner that limits or obstructs the sight distance of motorists entering or leaving intersections. *Please survey your property and clear, cut back, and clean up any sight obstructions.*

## **CITY NEWS**

City Council held a Budget Retreat in March of 2023 to explore cost saving measures and new revenue sources. There was projected to be a budget deficit in 2024 in the general fund. Basic city service levels could suffer reduction without implementing new revenue sources or fee increases. After discussion, Council made the difficult decision to establish new revenues and fee increases.

It was important to Council that the effect of the increases don't burden our residents any more than they have to, so various options were considered and approved that spread the costs out to different groups of people.

#### **HOW THIS WILL AFFECT YOUR UTILITY BILL**

Beginning in January of 2024 the following utility billing changes will be implemented:

#### **UTILITY TAX**

You will see an increase to the utility bill you receive at the beginning of February 2024. The city established a 10% utility tax on the gross revenues of water, sewer, and garbage charges. It's expected to generate additional revenue to help maintain current levels of city services.

Most of the other cities in our region have already established utility taxes for their utility customers, so Union Gap has been unique in that they have not done so in the past. Comparative tax rates were compiled for our region and the average utility tax for water is 24%, sewer is 22.6%, and garbage is at 21.2%. Union Gap decided to establish a utility tax of just 10%, because, it was important to the council to establish the minimum amount of utility tax needed. Those affected will be water, sewer, and garbage customers.

#### **UTILITY PENALTY FEES**

The city currently bills for utilities each month but allows two months of billing to accumulate before the bill is considered delinquent. In some cases this causes hardship on utility customers who wait to pay their bill until the second month, as it is much higher. This also affects the city who has to carry that debt, as well as the property owner who is ultimately responsible for the bill.

The city compiled utility penalty fees for our region and found the average utility penalty fee to be around \$12.28. The city decided to implement a \$10 utility penalty fee for those who are late in paying their utility bill. The city is also changing utility bills being considered delinquent monthly instead of bi-monthly. This should be more efficient in billing and collecting the fees. In many instances the residents find it difficult to pay utility bills that include two months of charges rather than one month.

The current due date for utility bills are the 10th of each month and that will not change. If a utility bill is not paid by the 11th then a \$10 fee will be assessed and a late notice will be sent as a reminder to pay the bill within 10 days to avoid disconnection. Those affected by this change will be utility customers who are delinquent on their utility bill.

#### **FEE INCREASES**

Beginning in January of 2024 the following fees will be increased:

#### **IMAPACT/DEVELOPER FEES**

The City considered the impact of development within the City and found that construction and development of dwelling units, commercial and industrial manufacturing buildings and structures, places demands on municipal government to provide new services and expand and improve public facilities. In order to provide an equitable source of funding for public facilities, it was determined to be necessary for the city to establish Impact/Developer fees. This will be a one-time cost of .65 per sq. ft. for residential, commercial, and industrial development.

The fees collected will be allocated as follows:

25% General Parks and Open Space

60% Streets/Roads

15% Fire

Those affected: Developers and home builders

#### **BUSINESS LICENSE FEES**

The city gathered comparative business license fees for our region and found Union Gap business license fees to be lower than average. The fees were adjusted to be more consistent with the average fees gathered.

Those affected: Business owners

#### **NSF FEES**

The city gathered comparative NSF fees for our region and found Union Gap fees to be lower than average. The fee was adjusted to be consistent with the average fees gathered.

Those affected: Customers who pay from an account with non-sufficient funds.

#### **PARK USE FEES**

The city gathered comparative Parks fees for our region and found Union Gap fees to be lower than average. The fees were adjusted to be more consistent with the average fees gathered.

Those affected: Residents and non-residents who reserve the parks and buildings.

If you do not get an answer right away, there is a good chance 911 is handling calls on their emergency lines and are unable to get to the non-emergency lines as quickly as normal.
