(CPL)

STEP 1: FILL OUT THE ATTATCHED APPLICATION AND SIGN ALL RELEVANT FORMS

*NOTE: All Non-United States Citizens are required under Federal Law to provide their Alien Registration card or I-94 card when applying for any firearms license or when making a firearms purchase. If you are not a United States citizen you will have to apply for a Concealed Pistol License Permit at Yakima County Sheriff's office.

The cost of the permit is non-refundable. Payment can be made in cash currency or check. Checks are to be made out to **Union Gap police Department**. Payment is required at the time the application is processed.

Costs of permits:

Original: \$52.50

Renewal: \$32.00

Late Renewal: \$42.00

Replacement Permit: \$10.00

STEP 2: SHOW YOUR CURRENT WASHINGTON STATE DRIVERS LICENSE/IDENTIFICATION WITH PHOTO (IF APPLICABLE) TO THE CLERK.

STEP 3: WE WILL DO A BACKGROUND CHECK ON YOU. FINGERPRINTS ARE REQUIRED FOR AN ORIGINAL PERMIT.

STEP 4: AFTER WE HAVE RECEIVED A CLEAR BACKGROUND CHECK ON YOU, WE WILL CALL THE NUMBER YOU PROVIDE ON THE APPLICATION TO NOTIFY YOU THAT YOUR PERMIT IS READY TO BE PICKED UP. FINGERPRINT BACKGROUND CHECKS ON ORIGINAL CPL'S REQUIRE 30 DAYS TO PROCESS. IF YOU ARE FOUND INELIGABLE TO OBTAIN A CONCEALED PISTOL LICENSE YOU WILL BE NOTIFIED VIA MAIL OR TELEPHONE.



Concealed Pistol License Application

You can use this form to apply for a concealed pistol license. To submit your application, you must:

- take any of the following items to your local law enforcement agency:
 - a photo ID such as a valid state driver license or state ID card
 - your permanent resident card, if you are a permanent resident alien
 - proof of 90 consecutive days of residency in Washington State
- pay the non-refundable \$52.50 fee in cash or check or money order made payable to your law enforcement agency.
- allow law enforcement to conduct a background check by signing and submitting your application when you are asked
 to do so. The background check will usually be completed within 30 days from the date you apply.
- · get fingerprinted by your law enforcement agency.

Notice

State and federal law makes it unlawful for you to possess and purchase a firearm or concealed pistol license if you have been convicted in any court for domestic violence. Federal law makes it unlawful for you to possess a firearm if you have been convicted in any court of domestic violence assault (felony or misdemeanor), regardless of the date of conviction.

A person is not considered convicted if he or she has received a pardon or has had his or her firearms rights restored by the appropriate court. This does not include certificates of rehabilitation issued by Washington courts.

Although state and local laws do not differ, federal law and state law on the possession of firearms may differ. You may be prosecuted in federal court if you are prohibited by federal law from possession of a firearm. A state license is not a defense to a federal prosecution.

The application fees for a concealed pistol license are non-refundable. If you are not sure you are eligible to possess a firearm, we encourage you to contact an attorney before submitting an application for a concealed pistol license.
