CONCESSIONAIRE RULES AND REGULATIONS

Concession Fee: \$30.00

Per day includes a 30'X30' area, which includes access to electricity and one (1) parking pass.

Requirements:

- Must have a current City of Union Gap Business License (\$25.00)
- Must provide a copy of current WA State Department of Health Food Handlers Permit for all who will be working
- Must provide a copy of current Certificate of Liability Insurance
- Must have all other required permits/license

Payment is due, for all dates reserved, at the time reservations are made. All payments are non-refundable and non-transferable. Daily set-up and take-down is required, unless fees are paid for consecutive days. The City is not responsible for concessionaire's equipment and /or equipment which remain in the park overnight. Concessionaire must remain in the assigned area at all times; movement and soliciting throughout the park is not permitted.

Payment Options:

Cash, Debit, Personal checks, Money Orders, Visa & Master Card are acceptable methods of payment.

Clean-Up & Damages:

Everything brought into the reserved area, must leave the area prior to each concessionaire leaving the park.

Assigned/rented area(s) must be left in clean, orderly conditions; trash must be picked up and placed in a garbage bin. In the even the City is required to repair damages, provide cleaning beyond normal routine cleaning; an extra cleaning fee may be billed to the person, signing the rental form/application, listed as the "Authorized Group Representative".

Liability Insurance Requirements:

A certificate of liability insurance is required and must accompany all requests. Coverage is as follows: Liability insurance coverage with the city of Union Gap and the City's officers, employees and agents named as additional insured parties; and affording death, personal injury and property damage liability coverage in the amount of not less than one million dollars (\$1,000,000). Additional endorsements for product liability are required in the event food, and/or beverages are to be dispensed.

The City of Union Gap must be listed as an additional insured.

Summary of Rules:

You should keep the completed reservation form and proof of payment in your concession vehicle at all times when vending on your approved date. Alcohol beverages are not allowed in Union Gap city parks; there is no camping at the Youth Activities Park; park in designated areas only absolutely no parking on the grass; speed limit 10 M.P.H

Driving Directions

Directions from I-82 to the Youth Activities Park: Take Exit #36 (Valley Mall Boulevard). Drive west on Valley Mall Boulevard for approximately 1.5 miles. Turn south (left) on South 3rd Avenue; continue to Ahtanum Road. Turn west (right) and continue for approximately ½ mile. The park entrance / exit are located on the south side of the road. There is a \$2.00 daily parking fee for each vehicle entering the park. All vehicles without a parking pass displayed are subject to a \$100.00 fine.
